FEEDING DIRECTIONS

CONSUMERS SUPPLY AUREO[®] 4G NO VITAMINS MEDICATED is designed to be fed as a top dress or thoroughly mixed in a ration to medicate feed with chlortetracycline.

10 mg/lb of bodyweight

2.5 pounds per 1,000 pounds of bodyweight

CALVES, BEEF AND NON-LACTATING DAIRY CATTLE: For the treatment of bacterial enteritis caused by *E. coli* and bacterial pneumonia caused by *P. multocida* organisms susceptible to Chlortetracycline. (10 mg/lb bodyweight per day) Feed 4 oz. per 100 pounds bodyweight per day. Treat for not more than 5 days.

BEEF CATTLE (OVER 700 LB.): For the control of active infection of anaplasmosis caused by *Anaplasma marginale* susceptible to Chlortetracycline. (0.5 mg/lb bodyweight per day) Feed 0.2 oz. per 100 pounds bodyweight per day (2 oz. per 1,000 pounds bodyweight).

SWINE: For the treatment of bacterial enteritis caused by *E. coli* and *S. choleraesuis* and bacterial pneumonia. Feed continuously for not more than 14 days at a rate to provide 10 mg/lb of bodyweight per day of chlortetracycline.

SHEEP: For the reducing the incidence of (vibrionic) abortion caused by *Campylobacter fetus* infection susceptible to Chlortetracycline. Feed 0.02 pounds per head per day (1 pound of this product will treat 50 head) to provide 80 mg. chlortetracycline per head per day.

CAUTION: Federal law restricts medicated feed containing this veterinary feed directive (VFD) drug to use by or on the order of a licensed veterinarian.

WARNING: A withdrawal period has not been established for this product in pre-ruminating calves. Do not use in calves to be processed for veal.
